Sub: Payment of Fees for the month of August, 2020/ 2<sup>nd</sup> Quarter 2020-21

Dear Parent(s)

The outbreak of COVID-19 pandemic paralyzed the normal life in almost whole part of the world including India. In order to contain the spread of above pandemic in India, the nationwide lockdown was imposed in whole of the country with effect from 25.03.2020 and all business/professional/other activities ceased to function.

Keeping in view the financial hardship of parents of students during lock down period, the Dte. Of Education, Govt. of NCT of Delhi vide its order dated 18.04.2020 directed the unaided recognized private schools to charge fees as under:

1. The fees to be charged on monthly basis.
2. No fee, except Tuition Fee will be charged from the parents during lock down period.
3. Annual and Development charges can be charged from the parents on pro-rata basis only on monthly basis after completion of lock down period.

In compliance of the directions contained in the above mentioned D.O.E order dated 18.04.2020, the school has charged only the monthly Tuition Fee( without any hike) during the period from April- July,2020.

The unlock-1 was implemented in NCT of Delhi with effect from 01.06.2020 and the business, professional and other activities started functioning again. The unlock-2 was implemented w.e.f. 01.07.2020 and further relaxations in commercial activities and other movements were allowed. Now, unlock-3 has been implemented w.e.f. 01.08.2020 and with the relaxations allowed, the life of people is returning to normal which amounts to completion of lockdown period.

Considering the need of the hour to provide more convenient and safe learning space for our students, the school necessitates to carry out the significant repairs and maintenance of school building and its installations. The school believes in ensuring the availability of essential requirements and sources of convenience for the students namely, clean Classrooms, Integrated Lab, Visual & Performing Arts Room, Rest rooms, Sanitized corridors, Ground area, Swing area, well-ventilated and equipped Library etc. Moreover, to provide the vital comfort and basic requirements of electricity and purified water and co-curricular activities respectively, the school has to meet various expenses on above mentioned facilities along with the AMC charges of installations. The Development Fee is to meet out the capital expenditure on purchase and replacement of furniture, fixtures and equipment etc.

In view of the above, your kind cooperation is solicited for making payment of Annual Charges & Development Fees on pro-rata basis along with the Tuition Fee for the month of August, 2020 and onwards. Hence, the bill towards payment of fees for the month of August, 2020 is being raised as under:
